## Agreement for Co-operation in Dealing with Pollution of the North Sea by Oil and Other Harmful Substances

## Bonn, 13 September 1983

**Entry into force:** 1 September 1989 in accordance with Article 19 (1) thereof: "This Agreement shall enter into force on the first day of the second month following the date on which the Governments of all the States mentioned in Article 18 of this Agreement and the European Economic Community have signed the Agreement without reservation as to ratification, acceptance or approval or have deposited an instrument of ratification, acceptance or approval."
